All AADA members are invited to attend the Reference Committee Meeting on Friday, October 17, from 1:30 to 3 pm at the Hilton Palacio del Rio Hotel in San Antonio. A brief recap of the resolutions to be considered:

- ▶ Approve the 2009 Budget.
- ▶ Approve the 2008-2009 Strategic Goals.
- ▶ Clarify the definition of Contributing Student Spouse Member in the Bylaws.
- ▶ Add District Trustee as responsible for filing names of member-at-large delegates, with the same deadline as for delegates from affiliated states.
- ▶ Request a change in AADA's Election Policy to allow a district trustee to make a mandatory endorsement of a candidate for office from an affiliated state.
- ▶ Request a change in AADA's Election Policy and subsequent Bylaw to remove the requirement that a mandatory endorsement be part of a candidate's application, but instead require a statement of the candidate's leadership experience and ability to fulfill the responsibilities of the elected office.
- ▶ Request a change in AADA's Election Policy to allow constituent presidents or treasurers to apply for an AADA officer position if they have served in their constituent positions for two years.
- ▶ Prohibit AADA Past Presidents from serving in any Board of Director's position after completing their term on the Board. (They could serve on the Advisory Council, committees, task forces, councils, and other non-board appointments.)
- ▶ Establish a standing AADA Council on Membership.
- ▶ Request that the AADA Board consider donating 3,000 *Dishing Up Smiles* books through a designed give away initiative and that the remaining inventory of books be kept on hand for future sales.

A summary of the resolutions is mailed to each member of the House of Delegates. However, any member may request a copy of a resolution by contacting AADA's Central Office at 800.621.8099 x 2865.

Lancaster County Component’s Holiday Card Sale raised thousands of dollars for the Water Street Mission Dental Clinic ● **Tennessee:** Produced a TV PSA to promote the use of mouthguards, featuring children and grandchildren of Alliance members ● **Utah:** Hosted a speaker at the Utah Annual Session on the power of community volunteering. It was a great pleasure to represent the Alliance at the second annual Give Kids A Smile Promising Practices Symposium June 12-14, 2008, at the ADA Headquarters. The best GKAS program planners nationwide share ideas, successes, frustrations, and passions to help all of us improve and/or expand our programs or start new programs. The Symposium was sponsored by the Dental Trade Alliance Foundation and was free of charge.

My knowledge of GKAS came from the DHE workshops at Conference 2008 in St. Louis. Dr. Jeff Dalin, founder of GKAS, was a featured speaker, telling us how GKAS has provided comprehensive dental care to low-income children since the first clinic in February 2002.

Dr. Dalin presented GKAS to the ADA. In turn, the ADA launched the program nation wide in 2003. Its dual missions are to provide free oral health care services to thousands of low-income children and highlight for policymakers the challenges these children face in accessing dental care.

A one-day event like Give Kids A Smile isn't a cure-all; it's a wake-up call. Our children deserve a health care system that addresses their dental needs. As your representative at the Promising Practices Symposium, I believe it is important for all of us to revisit the statistics.

The Surgeon General reports tooth decay as the most common chronic disease affecting American children, five times more common than asthma. Dental disease among low income families is epidemic. Eighty percent of children's tooth decay is found in just 25% of children. Approximately 25% of children rely on Medicaid for health insurance, but fewer than 25% of children enrolled in Medicaid see a dentist.

Infectious dental disease doesn't heal on its own. Research shows a definite link between dental disease and overall health. Dental care finally is gaining parity with medical care.

Since its inception in 2003, GKAS has reached several million children and involved hundreds of thousands of volunteers. The Alliance could benefit in several ways by becoming more involved in GKAS.

First, who does not want to help relieve a child's pain? Untreated dental disease affects a child's physical, emotional, and social development. Secondly, Give Kids A Smile is very important to the ADA. Our support of and involvement in the program will bolster the ADA's awareness of our value as an organization.

Bountiful information has been made available to us: individual dentist planning guides; guides to identifying children in need, forms regarding legal, risk management, HIPAA, consent, and medical history; group program planning and publicity kits for large program planners, etc.

The different directions we can take would be amazing. The promising practices from the symposium will excite and empower you with valuable ideas and methods that are being successfully done.

The Alliance has so much expertise as we come from different walks of life. We have much to give. We can educate parents and children on the importance of dental care, raise money from foundations and corporations, hold events, get local celebrities involved, serve food to volunteers, set up programs at State Capitols. We can do this!

We will hold a conference call on September 29, 2008, at 4:00 pm Eastern, to "Learn with the Alliance: Give Kids A Smile Best Practices." Join us to hear highlights of the ADA GKAS Best Practices symposium. But best of all, come hear fresh ideas and brainstorm about YOUR programs. I know many of you are already involved in GKAS, so please join us to help the rest of us come on board!

Surviving spouses deserve care and information to help them deal with their loss and its consequences. AADA members receive a note of condolence with a book about grief. This is followed by a letter and a packet of information about dealing with an ongoing dental practice and other issues. A year later, Alliance members receive a note and a pamphlet, "On the First Anniversary of Your Loss." Alliance members who are widowed and survivors of ADA members in good standing may continue in or join the Alliance by paying Alliance dues.

As long-time sponsors and friends of the Alliance, we at the ADA Insurance Plans appreciate the opportunity to visit with you in this column about your family's insurance needs and our activities in support of organized dentistry. I'm delighted to be writing the column starting this month.

As some of you know, I'm spending a lot of time these days speaking with dental students, new dentists, and their spouses by phone, via e-mail, and through visits to dental schools and other events across the country. My mission is to listen, observe, and share important facts and how-to's about insurance with these young people. A few of my observations may offer some take-away ideas for you, too—ideas that might be useful to the Alliance as you develop your own strategies to reach out to student spouses.

Student spouses appreciate personal finance information.

Whenever I talk with student spouses, I'm struck by how attuned they are to the couple's finances. Often, the spouse takes on the role of the family's "chief financial officer." The spouse quickly grasps the risk of being uninsured, and often advocates getting life and disability insurance to cover the family's risk exposures. Budget-conscious young spouses especially appreciate learning that dental students can get \$50,000 in ADA life insurance absolutely free, and \$2,000 in monthly disability insurance for just \$60 a year.

Take-away idea: Motivate student spouses to attend functions by offering relevant, real-world, personal finance information—whether through a workshop, guest speaker, or appropriate handouts. And, if you know a dental student who has not yet taken advantage of the ADA's outstanding student insurance program, please urge him or her to sign up today.

Student spouses respond to new and actionable ideas.

Every young person I speak with is surprised to learn they don't have to die or become disabled to benefit from insurance. Both life and disability insurance can serve a very practical purpose as collateral for a practice loan, and students can take action now to get that insurance in place. It's not a really a new idea, but it's new to them. Young people also find it illuminating to think of insurance policies as "living, breathing animals" that need care and attention over the years, as the family grows and as the couple's finances evolve.

Take-away idea: Frame ideas in new ways to appeal to new (especially younger) audiences. Incorporate opportunities to put ideas into action when attracting student spouses to events and volunteer positions.

Nothing substitutes for the personal touch.

We're committed to one-on-one interaction with dental students and their spouses whenever possible because we know a personal touch can make all the difference when it comes to important family financial decisions. It's also why our Plan Specialists are available by phone—so members can get the information and guidance they need even from a distance.

Take-away idea: Recruit one family at a time. When progress seems slow, remember that every new member makes the organization that much stronger. And, never underestimate the impact that one person can make toward a long-term or seemingly insurmountable goal.
